THE NANYANG-ST GALLEN DOUBLE MASTERS PROGRAMME

Earn two Masters Degrees simultaneously:

- Master of Business Administration (MBA) offered by the Nanyang Business School, Nanyang Technological University (NTU), Singapore; and
- Master of Arts in Strategy and International Management (SIM) offered by the University of St Gallen, Switzerland.

Courses at the University of St Gallen are conducted in English.

Admission Requirements

You must gain admission into the Nanyang MBA at the NTU in order to be eligible for this Double Masters programme. The admission requirements are:

- a good Bachelor's degree;
- at least two years' management, professional or other relevant experience at the time of admission;
- a Graduate Management Admission Test (GMAT) score of 600 or above; and
- a good command of English (Test of English as a Foreign Language or TOEFL IBT score of 100 or above is required if English was not the medium of instruction at tertiary level)

(Outgoing applicants from NTU must be of a non-European nationality.)

Course Requirements

You must meet the course requirements of both the Nanyang MBA and the St Gallen's SIM programmes:

- complete all requirements of the Nanyang MBA programme at NTU before joining the full-time St Gallen SIM programme;
- spend at least 2 semesters at the University of St Gallen;
- offer 62 ECTS of the SIM programme, including the completion of a Master thesis supervised by a St Gallen professor; and
- obtain a pass in a German language course.

Estimated Costs

Participants will pay:

- Programme fees of the Nanyang MBA;
- Personal expenses incurred while studying at the University of St Gallen. The estimated cost of living expenses is approximately CHF2,000 – CHF2,500 (S\$2,900 – S\$3,600) per month; and
- Cost of basic Swiss health insurance to satisfy student work permit requirements.
